JANUARY 3, 2019 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS

The Nuckolls County Board of Commissioners met Thursday, January 3, 2019 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of December 17, 2018. Keifer, Zikmund and Blackstone present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 9:15 a.m. **Blackstone made a motion to approve the Agenda and the December 17, 2018 minutes Seconded by Zikmund. Zikmund, Blackstone and Keifer voted Aye. 0 voted Nay. Motion Carried.**

The First order of business is to appoint a new chairman for 2019 under the Reorganizational Meeting. **A motion was made by Blackstone to appoint Timothy Zikmund as Chairman of the Board of Commissioners for 2019 and Keifer seconded the motion. Keifer, Zikmund and Blackstone all voted aye, 0 voted nay. Motion carried.**

Chairman Zikmund then took over conducting the meeting. The Reorganizational Meeting continued.

A motion was made by Zikmund to approve Resolution 01-19R to Appoint Daren Blackstone as Acting Chairman of the Board of Commissioners for 2019 and Keifer seconded the motion. Keifer, Zikmund and Blackstone all voted aye, 0 voted nay. Motion carried.

A motion was made by Blackstone to approve Resolution 02-19R, Authorizing Deposits Secured by Pledged Assets, which authorizes Vicki K. Ensign to deposit county funds, collected by her in her official capacity in banks in Nuckolls County, Nebraska and Zikmund seconded the motion. Zikmund, Keifer and Blackstone all voted aye, 0 voted nay. Motion carried.

A motion was made by Zikmund to approve Resolution 03-19R, Designating Banks and Authorizing County Treasurer to Invest County Funds. The Resolution lists the banks for the Pledged Securities and the amounts for the Treasurer and County Clerk. Blackstone seconded the motion. Keifer, Zikmund and Blackstone all voted aye, 0 voted nay. Motion carried

A motion was made by Blackstone to approve Resolution 04-19R to Appoint Dr. Blecha as County Physician for 2019 and Zikmund seconded the motion. Zikmund, Keifer and Blackstone all voted aye, 0 voted nay. Motion carried.

A motion was made by Blackstone to approve Resolution 05-19R to Designate the Official County Newspaper as The Superior Express for 2019 and Zikmund seconded the motion. Zikmund, Keifer and Blackstone all voted aye, 0 voted nay. Motion carried.

A motion was made by Keifer to approve Resolution 06-19R to Designate the Official County Newspaper For Publication of Delinquent Tax List as The Nuckolls County Locomotive Gazette for 2019 and Blackstone seconded the motion. Blackstone, Zikmund and Keifer all voted aye, 0 voted nay. Motion carried.

The Nuckolls County Board of Commissioners met Monday, January 7, 2019 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of January 3, 2018. Keifer, Zikmund and Blackstone present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 8:30 a.m. **Blackstone made a motion to approve the Agenda and the January 3, 2018 minutes. Seconded by Keifer. Zikmund, Blackstone and Keifer voted Aye. 0 voted Nay. Motion Carried.**

Larry Cerny, Fillmore County Commissioner and Nirma Board Member, presented the board with plaque from Nirma. The plaque is gift from Nirma celebrating 30 years of Nuckolls County membership. Nuckolls County was one of the original 32 counties that started Nirma in the 1980's. Now Nirma has grown to serving and insuring more than 90 organizations.

A motion was made by Zikmund for the Chairman to sign letter to Emergency Management Agency and another to Nebraska Department of Transportation. Seconded by Blackstone. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

A motion was made by Blackstone to approve Electrical Easement between Nuckolls County and Darrell Keim Farms. Seconded by Keifer. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

A motion was made by Zikmund to approve Resolution Directing Highway Superintendent to Conduct a Road Vacation or Abandonment Study on Road North and South County Road between Sections Sixteen (16), and Seventeen (17), and between Twenty (20) and Twenty-one (21), all in Township One (1) North, Range Eight (8). Seconded by Keifer. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

A motion was made by Zikmund to approve Special Designated Liquor Licenses for Meyer Vineyards, Inc., dba Superior Estates Winery for dates; January 25th & 26th, 2019, February 1st & 2nd, 8th & 9th, 15th & 16th, 22nd & 23rd, March 1st & 2nd, 8th & 9th, 15th & 16th, 22nd & 23rd and 29th & 30th, 2019. Seconded by Blackstone. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

Sheriff Baker reported to the board that the Sheriff's Department had been called for someone possible being in the Road Department yard outside of business hours. Baker stated the Sheriff Department responded to the call and noted obvious tracks but the intruder was gone. Baker suggested the county purchase cameras for the Road Department yard.

Treasurer Ensign presented semi-annual report.

Elledge presented Emergency Management/Noxious Weed updates.

A motion was made by Blackstone to accept the County Court, County Treasurer, Sheriff, Clerk of the District Court and County Clerk Monthly Board reports as submitted. Seconded by Keifer. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

JANUARY 22, 2019 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS

The Nuckolls County Board of Commissioners met Tuesday, January 22, 2019 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of January 7, 2018. Keifer, Zikmund and Blackstone present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 8:30 a.m. **Blackstone made a motion to approve the Agenda and the January 7, 2019 minutes. Seconded by Keifer. Zikmund, Blackstone and Keifer voted Aye. 0 voted Nay. Motion Carried.**

The board held a telephone conference with District Court Judge, Honorable Stephen R. Illingworth. The board initiated said telephone conference and said conference was recorded by stenographer at the request of Judge Illingworth. To begin the discussion the board requested Judge Illingworth explain the authority he had to order the board with regard to the courthouse. Judge Illingworth read then Nebraska State Statue 23-120(1) stating;

The board shall keep such buildings in repair and provide suitable rooms and offices for the accommodation of the several courts of record, Nebraska Workers' Compensation Court or any judge thereof, Commissioner of Labor for the conduct and operation of the state free employment service, county board, county clerk, county treasurer, county sheriff, clerk of the district court, county surveyor, county agricultural agent, and county attorney holds his or her office at the county seat and shall provide suitable furniture and equipment therefor. All such courts which desire such accommodation shall be suitably housed in the courthouse.

Judge Illingworth further stated that though not necessary, he had previously conferred with, and has the support of, the Chief Justice of the Nebraska Supreme Court with regard to the maintenance of the courthouse. Judge Illingworth expressed concern for the welfare health and safety of the individuals whose offices were housed in the building. Commissioner Blackstone explained that the board did intend to mitigate the bats but had put the plan on hold as they believed it was best to pursue after the bats were out of hibernation. Judge Illingworth agreed to attend the February 4, 2019 Board of Commissioner meeting to help the board review bat mitigation bids.

A motion was made by Blackstone to approve Sheriff Department Building Purchas Proposal. Seconded by Zikmund. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

A motion was made by Blackstone to approve Annual Noxious Weed Reports to the State of Nebraska as presented by Elledge. Seconded by Keifer. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

Chairman Zikmund recessed the regular Board Meeting at 10:00 a.m. to enter Board of Equalization meeting.

Chairman Zikmund reconvened the Board of Commissioners meeting at 10:06 a.m.

Jason Weigle of the Nuckolls County Extension Office was rescheduled due to travel conditions.

Cindy Buescher, Executive Secretary and Jimmy Bolte joined the meeting for the road department update. Their discussion included; guys are pushing snow as needed, doing maintenance on trucks and motor graders. Buescher stated she has applied for the tire recycling grant and they have been working on the 1 & 6 year plan.

A motion was made by Blackstone to approve the Chairman to sign the Certification of County Highway Superintendent for Jeff Wagner for December 17, 2018 to December 31st, 2018. Seconded by Keifer. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

A motion was made by Zikmund to approve Easement for Water line between Nuckolls County and Don Betten for 435 feet North from the SW Corner of Section 3, T3N-R5W (Elk Prec.) running across the common 66' ROW into the SE Corner of Section 4, T3N-R5W (Elk Prec.), Nuckolls County Nebraska. Seconded by Keifer. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.

A discussion was held about purchasing camera for the Nuckolls County Road Department Yard. Commissioner Blackstone will call around and gather some quotes for the next meeting.

Henry Pierce and Daniel Pierce joined the meeting to discuss options for implementing radios and GPS to Road Department equipment and vehicles. Pierce presented 2 different radio options. The board asked that this discussion be put back on the agenda for the next meeting. No action was taken.

A motion was made by Zikmund to approve Pledged Securities and Releases presented by Treasurer Ensign. Seconded by Blackstone. Zikmund, Blackstone and Keifer all voted aye. 0 voted nay. Motion carried.
