The Nuckolls County Board of Commissioners met Monday, January 4, 2021 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of December 21, 2020. Keifer, Zikmund and Mussmann present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 8:30 a.m. Commissioner Mussmann was sworn into office.

Chairman Zikmund recessed the regular Board Meeting at 10:08 a.m. to enter Board of Equalization meeting.

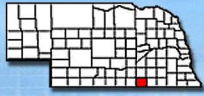

There being no further business the meeting was recessed at 10:47 a.m. until Monday, January 3, 2022.

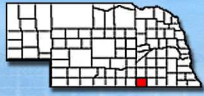
